Analysis:

\$145.00 per hour plus round trip travel time at \$95.00 per hour plus round trip mileage at \$0.85 per mile.

Testimony:

EUO, Arbitration, Courtroom Testimony is at the rate of \$195.00 per hour with a minimum billing of 4 hours (\$780.00), plus round trip travel time at \$95.00 per hour plus round trip mileage at \$0.85 per mile.

Travel time and mileage is earned once departure has been made for the EUO, Arbitration or Courtroom location. The 4 hour testimony fee is earned once the oath has been taken. Testimony over 4 hours is billed at \$195.00 per hour or each portion of an hour.

Depositions:

\$780.00 for a 4 hour block of time. Depositions that are taken at the opposing attorney's office or chosen location will incur additional costs for round trip travel time at \$95.00 per hour and round trip mileage at \$0.85 per mile. Travel time and mileage is earned once departure for the deposition site has begun. The 4 hour block of time is earned upon arrival at the deposition site and the scheduled time occurs.

All fees *MUST BE PREPAID 72 HOURS in ADVANCE of DEPOSITION by OPPOSING ATTORNEY. NO REFUND will be made of the initial 4 hour minimum payment if Cancellation is made by the opposing attorney with less than 24 hours advance notice. Further, if the deposition goes past 4 hours, a second check will need to be presented to pay for the additional time in the amount of \$195.00 per hour or each portion of an hour. If the second check is not presented, then the deposition will have to be rescheduled with the same original 72 hour prepayment receipt requirement for the next 4 hour block of time for \$780.00.*

NOTE: If the prepayment is not received within the required 72 hour advance notice interval, then the deposition will be required to be rescheduled. No travel will be made to the deposition site unless the prepayment has been received and deposited. Additionally, no travel will be made to the deposition site with an opposing attorney agreement to produce the prepayment check upon arrival.
