Cahanin meets the professional qualifications of NFPA 1033, Standard for Professional Qualifications for Fire Investigator as documented in a Florida declaratory statement held by no other fire expert in the state. Investigations include the Station Nightclub Fire in 2003 with 100 fatalities. In Wyatt v. Security Alarms Co., Inc. key testimony on the failure of a Viking automatic fire sprinkler established a product liability that resulted in a \$1.4M dollar jury award for Wyatt in Oklahoma. Specialty areas of forensic expertise include kitchen fire suppression systems, fire sprinklers, and fire alarm failures. Fire and Building Code construction defect findings are supported by 40 years of working with national codes and standards. Gregory Cahanin also performs code compliance and development for property owners and manufacturers.
