Additionally, in Mr. Plitt's capacity as an attorney directly representing insurance companies, he has oftentimes been called upon to provide informal advice and guidance regarding claim handling practices and procedures and possible revisions thereto. These discussions would take place with claim management professionals, including in-house counsel. Mr. Plitt also has experience handling claims on behalf of multiple insurance companies, including facilitating the claim investigation, processing, analysis, and evaluation in real-time.

Mr. Plitt has been invited by insurance companies to conduct in-house training seminars on claim handling, bad faith, and insurance regulations (including the NAIC Model Unfair Claims Settlement Practices Act and specific state versions of the Act).
